The APSSB conducted the Physical Standard Test / Physical Efficiency Test from 25-03-2022 to 06-04-2022 and written examination on 26-06-2022 for the posts of Forester and Forest Guard, which was advertised vide Advt No.09/2020 dated 21/01/2020 and subsequent notice No.13/14/2021 dated 29/12/2021 for the posts indicated as under:

3. The provisionally shortlisted candidates will have to mandatorily upload their documents by logging into the website [www.apssb.nic.in](http://www.apssb.nic.in) using their credentials from 01-07-2022 (10:00 am) to 11-07-2022 (03:00 pm). The following documents are to be uploaded:

- Matriculation certificate issued by the Board/University
- Class X or equivalent mark sheet and Pass certificate (for Forest Guard)
- Class XII or equivalent mark sheet and Pass certificate (for Forester)
- APST certificate (if applicable)
- Permanent Resident Certificate (if applicable)
- Intimation letter to HOD for those in regular Govt Service.

4. Failure to upload documents shall result in rejection of candidature and non-allotment of post.

5. The candidature of all the shortlisted candidates is PROVISIONAL and subject to their eligibility in all respects as prescribed in the Advertisement and Recruitment Rules. The candidates would be required to produce their latest original certificates / documents in support of their claim relating to age, educational qualifications, category etc., during verification of their documents.

6. The date of verification of documents has been fixed tentatively on 19-07-2022 at APSSB Office, C-sector, Itanagar from 10:00 am onwards. The shortlisted candidates should bring their original documents and photocopy of the documents mentioned at sl no. 3 along with 02 copies of recent passport size photo.

7. Candidates must note that their candidature is purely provisional at this stage and their appointment will be subject to their name figuring in the provisional select list which shall be prepared after the Document verification. Apart from that they should fulfil the eligibility criteria as per Advertisement No.09/2020 dated 21/01/2020, including possession of the requisite document, failing which their candidature may be summarily rejected at any stage.

8. Further, the Appointing Authority i.e., the indenting /user department verifies the character and antecedents of the candidates, authenticity of documents/ certificates and

eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional shortlisting of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
